AN ORDINANCE to redistrict the City of New Orleans, pursuant to Section 3-103(2) of the Home Rule Charter of the City of New Orleans, and otherwise to provide with respect thereto.

1 **SECTION 1. THE COUNCIL OF THE CITY OF NEW ORLEANS HEREBY**
2 **ORDAINS**, that in accordance with Section 3-103(2) of the Home Rule Charter of the City of New
3 Orleans, effective on the first Monday in May, 2014, the Council Districts of the City of New Orleans
4 shall be as follows:

5 **(A) District A** is composed of Precincts 3-14, 3-18, 3-19, 3-20, 4-7, 4-8, 4-9, 4-11, 4-14, 4-15, 4-17,
6 4-17A, 4-18, 4-20, 4-21, 5-8, less and except for that portion of 5-8 in District D as described
7 herein; 5-9, 5-10, 5-11, 5-12, 5-13, 5-15, 5-16, 6-8, 6-9, 7-12, less and except that portion of 7-
8 12 in District D as described herein; 7-17, 7-18, 14-1, 14-2, 14-3, 14-4, 14-5, 14-6, 14-7, 14-8,
9 14-9, 14-10, 14-11, 14-12, 14-13A, 14-14, 14-15, 14-16, 14-17, 14-18A, 14-19, 14-20, 14-21,
10 16-1, 16-1A, 16-2, 16-3, 16-4, 16-5, 16-6, 16-7, 16-8, 17-1, 17-2, 17-3, 17-4, 17-5, 17-6, 17-7,
11 17-8, 17-9, 17-10, 17-11, 17-12, 17-13, 17-13A, 17-14, 17-15, 17-16, 17-17, 17-18, 17-18A, 17-
12 19 and 17-20 of Orleans Parish.

13 **(B) District B** is composed of Precincts 1-1, 1-2, 1-5, 1-6, 2-1, 2-2, 2-3, 2-4, 2-6, 2-6A, 2-7, 3-1,
14 3-3, 3-5, 3-8, 3-9, 3-12, 3-15, 4-3, 4-4, 4-5, 4-6, 10-3, 10-6, 10-7, 10-8, 10-9, 10-11, 10-12,
15 10-13, 10-14, 11-2, 11-3, 11-4, 11-5, 11-8, 11-9, 11-10, 11-11, 11-12, 11-13, 11-14, 11-17,
16 12-1, 12-2, 12-3, 12-4, 12-5, 12-6, 12-7, 12-8, 12-9, 12-10, 12-11, 12-12, 12-13, 12-14, 12-16,
17 12-17, 12-19, 13-1, 13-2, 13-3, 13-4, 13-5, 13-6, 13-7, 13-8, 13-9, 13-10, 13-11, 13-12, 13-13,
18 13-14, 13-15, 13-16, 14-23, 14-24A, 14-25, 14-26 and 16-9 of Orleans Parish.

19 **(C) District C** is composed of Precincts 4-2, 5-1, 5-2, 5-3, 5-4, 6-1, 6-2, 6-4, 7-1, 7-2, 7-4, 7-5,
20 less and except that portion of precinct 7-5 that lies in District D, Precinct 7-6, less and except
21 that portion of precinct 7-6 that lies in District D, Precincts 8-1, 8-2, 8-4, 8-6, 9-9, 9-11, 9-12,
22 9-13, 9-14, 9-15, 9-16, 9-19, 15-1, 15-2, 15-3, 15-5, 15-6, 15-8, 15-9, 15-10, 15-11, 15-12, 15-
23 12A, 15-13, 15-13A, 15-13B, 15-14, 15-14A, 15-14B, 15-14C, 15-14D, 15-14E, 15-14F, 15-
24 14G, 15-15, 15-15A, 15-15B, 15-16, 15-17, 15-17A, 15-17B, 15-18, 15-18A, 15-18B, 15-18C,
25 15-18D, 15-18E, 15-18F, 15-19, 15-19A, 15-19B and 15-19C of Orleans Parish.

26 (D) **District D** is composed of Precincts 4-22, 4-23, 5-5, 5-7, a portion of 5-8, more particularly
27 described as follows: Beginning at the intersection of St. Louis St and N. Broad St., thence
28 northeast on N. Broad St. to its intersection with Saint Phillip St., thence southeast on Saint
29 Phillip St. to its intersection with N. Dorgenois St., thence southwest on N. Dorgenois St. to its
30 intersection with St. Louis St., thence northwest on St. Louis St. to the point of beginning; 5-17,
31 5-18, 6-6, 6-7, a portion of Precinct 7-5 being more particularly described as follows: beginning
32 at the intersection of St. Bernard Ave. and N. Claiborne Ave. then East on N. Claiborne Ave.
33 to the intersection with Elysian Fields Ave., then South on Elysian Fields Ave, to the
34 intersection with N. Robertson St., then West on N. Robertson St. to the intersection with
35 Pauger St., then South Pauger St. to the intersection with Marais St. then West on Marais St.
36 to the intersection with St. Bernard Ave., then North on St. Bernard Ave to the point of
37 beginning, a portion of Precinct 7-6, being more particularly described as follows: beginning at
38 the intersection of N. Claiborne Ave., and Esplanade Ave., then Northeast on N. Claiborne
39 Ave. to the intersection with St. Bernard Ave., then South on St. Bernard Ave. to the
40 intersection with Marais St., then West on Marais St. to the intersection with Esplanade Ave.,
41 then North on Esplanade Ave to the point of the beginning, 7-7, 7-8, 7-9A, 7-10, 7-11, a
42 portion of 7-12, more particularly described as follows: Beginning at the intersection of N.
43 Broad St. and Esplanade Ave., thence northeast on Esplanade Ave. to its intersection with
44 Columbus St., thence southeast on Columbus St. to its intersection with N. Galvez St., thence
45 southwest on N. Galvez St. to its intersection with Esplanade Ave., thence northwest on
46 Esplanade Ave. to the point of beginning; 7-13, 7-14, 7-15, 7-16, 7-19, 7-20, 7-21, 7-23, 7-24,
47 7-25, 7-25A, 7-26, 7-27, 7-27B, 7-28, 7-28A, 7-29, 7-30, 7-32, 7-33, 7-34, 7-35, 7-37, 7-37A,
48 7-40, 7-41, 7-42, 8-7, 8-8, 8-9, 8-12, 8-13, 8-14, 8-15, 8-19, 8-20, 8-21, 8-22, 8-23, 8-24, 8-25,
49 8-26, 8-27, 8-28, 8-30, 9-10, 9-17, 9-21, 9-23, 9-25, 9-26, 9-28, 9-28C, 9-28E, 9-29, 9-30, 9-
50 30A, 9-31, 9-31A, 9-31B, 9-31D, 9-33 and 9-42 of Orleans Parish.

51 (E) **District E** is composed of Precincts 9-1, 9-3, 9-3A, 9-4, 9-5, 9-5A, 9-6B, 9-6C, 9-6D, 9-6E, 9-
52 6F, 9-7, 9-8, 9-8A, 9-32, 9-34A, 9-35, 9-35A, 9-36, 9-36B, 9-37, 9-38, 9-38A, 9-39, 9-39B, 9-
53 40, 9-40A, 9-40C, 9-41, 9-41A, 9-41B, 9-41C, 9-41D, 9-42, 9-42C, 9-43A, 9-43B, 9-43C, 9-
54 43E, 9-43F, 9-43G, 9-43H, 9-43I, 9-43J, 9-43K, 9-43L, 9-43M, 9-43N, 9-44, 9-44A, 9-44B, 9-
55 44D, 9-44E, 9-44F, 9-44G, 9-44I, 9-44J, 9-44L, 9-44M, 9-44N, 9-44O, 9-44P, 9-44Q, 9-45 and
56 9-45A of Orleans Parish.

1 **SECTION 2.** That the precincts referred to in Section 1, hereinabove, shall mean those
2 precincts established by Section 58-36 of the Code of the City of New Orleans, however, nothing herein
3 shall be construed as limiting the power of the City of New Orleans to adjust precinct boundaries, in
4 accordance with applicable law, provided that the geographic boundaries of the council districts
5 described in Section 1, hereinabove, are maintained.

1 **SECTION 3.** That the Offices of Councilmember-at-Large and District Councilmember for
2 each of the districts and described and established in Section 1, hereinabove, shall be filled in the
3 election to be held for such purposes which shall be conducted pursuant to and in accordance with the
4 election laws of the State of Louisiana. Persons who seek to qualify for such offices shall qualify

5 pursuant to and in accordance with the provisions of Section 3-104 and related provisions of the Home
6 Rule Charter of the City of New Orleans and the election laws of the State of Louisiana.

1 **SECTION 4.** That immediately upon this ordinance being adopted by the New Orleans City
2 Council and Approved by the Mayor under the provisions of the Home Rule Charter of the City of
3 New Orleans, the City Attorney and the City Council staff and/or consultants engaged by the City of
4 New Orleans, shall promptly do any and all things necessary to obtain approval and pre-clearance of
5 the council districts as described hereinabove by the United States Department of Justice, pursuant to
6 the Voting Rights Act of 1965.

1 **SECTION 5.** All previously adopted ordinances in conflict herewith are hereby repealed.
